

**CONTRACT FOR THE FIRE PROTECTION AN AMBULANCE SERVICE
BETWEEN THE VILLAGE OF LYONS FALLS AND THE TOWN OF GREIG**

This agreement, made on the 1 day of Jan., 2015, between the Town of Greig, Lewis County, NY, hereinafter designated as party of the first part, and the Village of Lyons Falls, Lewis County, NY, hereinafter designated as party of the second part with the Lyons Falls Fire Department consenting hereto:

Witnessed, whereas there has been duly established in the said Town of Greig, Fire Protection Districts as recorded with the County of Lewis and whereas the contract has been authorized by the Town of the party of the first part, and the Village Board of the party of the second part for the protection and ambulance service to the said District upon the terms provisions herein set forth and whereas this contract is to bind the parties as herein set forth.

NOW THEREFORE. The party of the first part does engage the party of the second part to furnish FIRE PROTECTION and AMBULANCE SERVICE to the said District and the party of the second part, through cooperation in the manner following, to wit:

1: The Fire Department of the second part shall at all times during the period of the AGREEMENT be subject to call for attendance upon any fire, and/or ambulance service occurring in the said district, such Fire company shall respond and attend the fire or respond to the ambulance call without delay and one or more companies with suitable equipment for pumping and trained personnel of the party of the second part.

2: In consideration of furnished aid and the use of its apparatus as aforesaid, the party of the second part shall receive the following sum:

That the yearly amount shall be due and payable on or before the 31st day of December of the year shown. In the event the party of the second part, for the different sum, or in the further event the party of the first part wishes to change the aforesaid amount, the Contract may be amended by a brief supplemental contract. Any application by the party of the second for a change in the sum shall be made to the party of the first part on or before October 1st of each year. Such changes shall be subject to a public hearing as provided by law.

3: All monies to be paid under provisions of this contract shall be a charge upon the said Fire Protection District to be assessed and levied upon the taxable property in the said District and collected with Town Taxes.

4: Members of the Lyons Falls Fire Department, while engaged in the performance of their duties in answering, attending upon or returning from any call provided by the contract shall have the same rights and privileges and immunities as if performing the same in the Village of Lyons Falls.

Page 2 – LYONS FALLS FIRE AND AMBULANCE CONTRACT

5: This agreement shall be effective as of the first day of January 2015, and for a period of three (3) years from said day of January 2015, and thereafter until termination by service of thirty (30) days notice in writing by either party upon the other, but in any event shall terminate three (3) years from the original effective date hereof. The notice herein provided may be served in writing as above or personally, upon those individuals upon which a summons in Supreme Court would require to be served.

IN WITNESS WHEREOF, these parties have executed this Agreement and Contract and caused same to be dated the day, year and month set forth above.
